Your pet's health and safety during their stay is our staff's main priority.

We provide bedding/beds. If you need to bring a bed, please identify the bed with your name.

I agree to make complete payment to Riverside Drive Animal Care Center at time of discharge. I understand that if I fail to pick my pet up within 10 days of the date above and do not notify RACC, my pet will be considered abandoned, and as such, will be handled in accordance with Ohio state law.
